Veterano de la Segunda Guerra Mundial, Ken Cooke, comparte sus recuerdos del Día D

El veterano de la Segunda Guerra Mundial, Ken Cooke, de 98 años, comparte sus recuerdos del Día D, 80 años después del desembarco de Normandía.

Cooke, el último hombre de la Asociación de Veteranos de Yorkshire Normandía, recuerda cómo se unió al ejército en 1943 y fue entrenado durante seis semanas antes de ser enviado a Francia en junio de 1944.

En una entrevista con el periódico británico The Guardian, Cooke describe cómo se unió al ejército después de trabajar como mensajero en una fábrica de municiones y cómo fue entrenado durante seis semanas antes de ser enviado a Francia en junio de 1944.

Cooke recuerda cómo desembarcó en la playa de Gold con la 7ª batallón de los Green Howards y cómo avanzó a través del campo hasta llegar a las trincheras alemanas. No recuerda haber disparado su arma durante el primer día, pero recuerda haber visto a algunos alemanes que se hacían los muertos en el lado de la carretera.

Cooke también comparte sus recuerdos de cómo fue herido un mes después del desembarco y cómo fue tratado en un hospital de campaña junto a soldados alemanes. Después de ser dado de alta, fue enviado de vuelta a Inglaterra para ser tratado y rehabilitado. Después de recuperarse, fue enviado de vuelta al frente en febrero de 1945, donde luchó hasta el Rin.

Cooke finalmente terminó la guerra en las afueras de Bremen, donde se estableció en trincheras y luchó contra los alemanes que se acercaban. Después de la guerra, Cooke trabajó en la compañía de dulces Rowntree's en York, donde conoció a su esposa, Joan, y se retiró más de cuatro décadas después.

Cooke ha hablado abiertamente de sus experiencias de guerra en los últimos años y ha participado en la creación de una obra de teatro verbatim ganadora de premios, Bomb Happy, y una placa conmemorativa en la iglesia de St Lawrence en York.

Sin embargo, recordar puede ser difícil. "Las cosas vuelven a ti cuando ves cosas", dice Cooke. "Solía tener flashbacks, pero gradualmente, cuando me uní a la asociación de veteranos, hablar con los veteranos... me ayudó a deshacerme de esos recuerdos. Algunas cosas nunca se van".
